

**EPIC WATERS NAMED A TOP TWO INDOOR WATER PARK IN THE U.S.**



Epic Waters Indoor Waterpark, 2960 Epic Place, was awarded the second spot for the Best Indoor Water Park by USA Today 10Best Readers' Choice 2024 Travel Awards! The Top 10 parks received the most votes from 20 indoor water parks nominated by a panel of experts as the top indoor water parks in the United States. To be crowned one of the best, fans were asked to vote for their favorite park online over a four-week period.

“To be ranked among the top ten best water parks in the nation for a second consecutive year brings us great pride,” said Mayor Ron Jensen. “We are getting closer to becoming the top destination thanks to the support of our loyal customers and to the strong partnership between the City and American Resort Management.”

**ELEVATED ARTISTRY**

Renowned artist Eric Henn is currently bringing his creative vision to life on Grand Prairie’s elevated water storage tank, situated just east of SH 161 and north of Marshall Drive. Scheduled for completion and activation by October 2024, this new tank will hold 2 million gallons of water—doubling the capacity of the old tank and will serve EpicCentral, Traders Village and surrounding neighborhoods. The old water tank will eventually be demolished.

## COMMON ITEMS THAT ARE POISONOUS TO CATS

You may be surprised at how many things you use, eat, or decorate with pose a risk to your feline friends. In general, if it will harm you, it will most likely harm a cat. Keep all cleaning products, chemicals, and medications in places your cats cannot access. Store them in child-proof containers out of reach.

- **Anti-freeze.** This is a common cause of poisoning in the wintertime. If you spill antifreeze, even out on a driveway or street, clean it up immediately.
- **Houseplants and flowers.** Many common plants found in bouquets are poisonous for cats. Lilies, chrysanthemum, azaleas and rhododendrons, tulips and daffodils, and sago palms are all poisonous. Poinsettias, common during the holiday season, are also toxic for cats. Do careful research and opt for plants that won't cause problems if your cat happens to nibble on them. Keep any toxic plants in your home well out of a cat's reach.
- **Insecticides.** These chemicals can cause a problem if your cat grooms herself after walking or laying in a recently treated area. Avoid using these products and instead consider humane and natural methods to address issues with insects.
- **Rat and mouse poison.** Rodenticides could be ingested directly by a cat, or indirectly if a cat eats a rodent that has ingested the poison. Avoid using them and consider humane and natural methods to address issues with rodents. If you decide to buy these poisons, store them in metal cabinets out of reach and alert your neighbors when the poison is in use.
- **Cleaning products.** Store all bleach, laundry detergent, surface cleaners, carpet cleaners, toilet bowl cleaners, and other such products in pet-inaccessible areas of your home.
- **Our food and drink.** Many of us enjoy chocolate, alcohol, coffee, tea, energy drinks, onions, garlic, gum, or candy. However, all these things can be toxic for cats. To be safe, it's best to never give your cats any people food.

## INTENTIONAL POISONING

It's difficult to imagine anyone capable of harming or killing animals. Unfortunately, intentional poisoning of cats can and does happen.

Intentionally poisoning a cat is animal cruelty and is a crime in the United States. If you are aware of cats who are being poisoned or threatened with poison, understand that you have power to save their lives through the law.

- Call Animal Services at 972-237-8575 if you witness someone poisoning community cats as soon as possible, explaining the situation in careful detail. Have a clear written statement on hand that describes the incident and all relevant dates and times.
- Document the evidence. If it doesn't require entering another person's property without their permission, take photographs, hard as it may be, of any evidence that a cat has been harmed, killed, or threatened by poison. Be sure to document the contact information of anyone with firsthand information on the incident, as well as any emails, written notes, voicemails, or other communications that contain poisoning threats or admissions. Include them when you file your police report.

## COMMUNITY RATING SYSTEM AND FLOOD ASSISTANCE INFORMATION

The City of Grand Prairie participates in the Community Rating System (CRS). The CRS is a subset of the National Flood Insurance Program (NFIP). This voluntary incentive program recognizes and encourages community floodplain management activities that exceed the minimum NFIP requirements. As a result, flood insurance premium rates are discounted to reflect the reduced flood risk resulting from the community's actions meeting the three goals of the CRS: 1) Reduce flood losses, 2) Facilitate accurate insurance rating, and 3) Promote the awareness of flood insurance. Based on the city instituting higher standards related to floodplain management, the city was awarded a class 4 ranking, effective in October 2023, which qualifies residents for a 30 percent discount on flood insurance premiums.

The city's Storm Water Utility Team can provide information about properties impacted by floodplains, as well as the city's floodplain management standards. ## POWER OUTAGE SAFETY

Power outages can happen anytime, anywhere. Outages are most likely to occur during periods of severe weather, extreme heat/cold, and high electricity usage periods ( 4 p.m.-10 p.m.).

Safety tips during a power outage:

- Keep freezers and refrigerators closed
- Do NOT use a gas stove or oven to heat your home
- Have alternate plans for refrigerating medicines or using power-dependent medical devices
- Never use a generator near windows, vents, or in a garage
- When in doubt, throw it out! Throw away any food that has been exposed to temperatures 40 degrees or higher for two hours or more, or that has an unusual odor, color or texture.
